All above should be packed in a specially designed canvas bag.

1	INSPECTION	The Analysis Kit will be pre-inspected by Regional Manager of KSWC at destination(stock receive point) as per specifications terms & conditions of Supply Order issued and after satisfactory reports from Inspecting officer of the corporation the stock will be accepted. Pre-Inspection reports & stock certificate of Regional Manager must be submitted by supplier along with Invoice for payment.
2	PAYMENT	The Payment will be made on receipt of consignment at destination in good condition and receipt of satisfactory Inspection reports and confirming to ISI specification. In case the material found defective at destinations, the same will be replaced by you at free of cost. The claim for shortages damages if any, will also be settled directly by you with the Insurance company for which the consignees will furnish the requisite information. The material despatch should be insured in favour of Karnataka State Warehousing Corporation against each consignment.
3	MANUAL	Each instrument shall be supplied with operational manual. The Supplier personally should be explained to our warehouse Manager or Regional Manager to-handle the items as soon as stock received at destination. The supplier should supply the manual and brochures along with the items.
4	DELIVERY:	The entire quantity shall be delivered within 10 days to the following destination.
5	DEMONSTRATE	The Supplier should demonstrate of all the items supplied. The demonstrate certificate should be produce along with invoice for payment.

II. Documents to be submitted through online e-procurement portal for acceptance of technical Bid

The Bidder should submit the following documents for acceptance of technical bid through online e-procurement portal.

1. The Tenderer should submit copy of proof for EMD amount remitted through e-procurement portal.
2. The copy of the valid license and registration certificate issued by the competent authority.
3. The copy of supply order issued by the central/state government, government undertakings/Boards/Corporations
4. Undertaking letter by the tenderer for guaranty/warranty in 1 year.
5. The Tenderer should furnish copies of Certificates issued by Chartered Accountant for the turnover for the year 2016-17.
6. The Copy of Income Tax Returns filed for the year 2016-17.
7. The Copy of Self declaration of ineligibility corrupt and fraudulent practices issued by any State Government / Government of India /Union Territory.
8. The copy of the PAN card.
9. The copy of cancelled cheque with name pre-printed, IFSC code, Account Name and Number, Bank Name and Bank Address.

The tenderer should submit the above documents through online e-procurement portal failure to which the technical bid of the tenderer will be rejected.

III. TERMS AND CONDITIONS

1. The tender for supply of analysis kits have been invited as per The Karnataka Transparency in Public Procurement Act, 1999 and Rules 2000. Accordingly two cover bid system consisting of Technical bid and Financial bid shall be followed.
2. The Financial bid of the tenderer shall be opened only of the tenderer who qualifies in the Technical bid.
3. The tenderer should furnish Earnest Money Deposit (E.M.D) through online. The E.M.D shall be liable to be forfeited if the tenderer does not fulfill tender conditions. The EMD of successful/unsuccesful tenderer will be refunded after finalisation of the tender. The EMD amount will not carry any interest.
4. The Successful tenderer shall furnish security deposit @ 5% of the total value of the ordered quantity of analysis kits in the form of Demand Draft drawn in favour of **The Managing Director Karnataka State Warehousing Corporation Bangalore** within 7 days from the date of receipt of supply order. The security deposit will be refunded only after one-year from the date of supplied OR supplied quantity exhausted whichever is earlier. The security deposit does not carry any interest. The E.M.D of the successful tenderer shall not be adjusted towards the security deposit. The security deposit will not carry any interest.

5. The tenderer quoted rate will be inclusive of Central and State sales tax, excise duty, GST, octroi charges and all other taxes levied or may be levied in future without submission of form "C" and "D" or any other similar form prescribed under any relevant Act in force delivery on F.O.R, door delivery basis to the Regional Offices/Warehouses. The transportation charges, loading/unloading charges should be borne by the supplier.
6. Once the rate accepted by the corporation will not be increased. Any request to increase the rates will not be considered during the one year period or extended period of two months.
7. The tenderer should quote rate per a analysis kit only in financial bid at e-procurement portal. The rate quoted shall be valid for a period of one year or extended period of two months from the date of acceptance of the tender rates.
8. This is the tender of Annual rate contract. The corporation will place one or more supply orders as per the requirements of corporation.
9. The tenderer who has signed the tender should be present or may depute his/their authorized representative to be present at the time of opening of tender if they so desire, along with the authority letter duly attested.
10. Each tenderer should mention his postal address with pin code, phone number, fax number, e-mail etc. The KSWC will not be responsible for any non-receipt of information furnished by the tenderer with incorrect postal, email etc. information.
11. The material should be dispatched & covered under transit insurance for dispatch to the Regional Offices located at Mysore, Bangalore, Hubli, Davanagere, Shimoga, Gulbarga and Raichur and warehouses located at Karnataka State.
12. The material should be delivered on F.O.R. basis, door delivery basis only in case of any un-specification, damages or shortages, found at the destination, should be replaced by the tenderer at free of cost.
13. The supplier should be offered for pre - inspection at a time for supply of ordered quantity within 20 days from the date of supply order. The material shall be of recent manufacture, which should not be more than one month old from the date of offered for pre-inspection. The supplier may ask for pre-inspection at his premises, If stock Pre- inspection at supplier premise the same should be dispatch within 7 days of confirmation, dispatch order received from this office. However the corporation has right to insist for Pre-Inspection at KSWC Stock receiving places & the material should be dispatch within 7 days of confirmation, dispatch order received from this office for pre-Inspection and to receive the material at KSWC places. The Regional officer of KSWC will Pre-Inspected the materials at stock receiving KSWC places. If the supplier fails to offer for pre-inspection OR to deliver the analysis kits within the stipulated time, penalty will be imposed as decided by Managing Director, KSWC.
14. The payment for materials shall be made only after receipt of proof of dispatched documents and receipt of stock certificates from the Regional/Warehouse Managers, that the stocks are received in good condition.
15. The product shall be guaranty and warranty for a period of one year from the date of manufacture.
16. The successful tenderer should execute an agreement on Stamp paper for supply of materials as per tender condition within 7 days from the date of intimation of accepted rate. There should be no escalation clause in the tender.

17. The Managing Director, KSWC reserves the right to increase or decrease the quantity mentioned in the tender.
18. The Managing Director, KSWC reserves the right to accept or reject the tender without assigning any reasons.
19. The rates quoted in tender shall remain valid for a period of one year or extended period of two months from the date of issue of rate acceptance order as desired by the Corporation.
20. The tenderer shall be bound to make supply as per the tender specifications, terms & conditions during the period of one year or extended period of two months.
21. The submission of tender by the tenderer implies that he has read the notice, specifications terms & conditions make himself aware of all the stipulation made therein.
22. The materials should be packed and dispatched properly to avoid damages during the transit. In case if any damages, shortages unsized, unspecification, materials found at the destination the same will be replaced by the tenderer at free of cost.
23. The Corporation will call L1 Tenderer for rate negotiate meeting & to verify uploaded of tender documents with original documents. The uploaded online documents must be same to the furnished original documents.
24. The opening of Technical Bid or Financial Bid will be opened on next working day, if any general holiday declared on schedule date.
25. In the event of any breach of terms, conditions of this tender, the Managing Director, KSWC shall have all the right to terminate the order and forfeit the EMD, security deposit or any appropriate action deemed fit by the Managing Director towards recovery of amount due towards damages or expenses that will be incurred by the Corporation for the default of the supplier under the tender as their in stated above. Further the successful tenders shall be black listed and intimated to the concerned.
26. The successful tenderer fails to do or comply with any terms and conditions of the tender, the Managing Director, KSWC shall have all the right to cancel the tender and call for fresh tender. In such case E.M.D and security deposit furnished by the tenderer shall be forfeited without a prejudice to the other right legally available and call for fresh tender at his risk and cost and the tenderer liable to make good the difference or loss to the Corporation.
27. In the event of any question, dispute or difference arising in any way shall be referred to the sole arbitration of Managing Director, Karnataka State Warehousing Corporation, Bangalore whose decision in the matter shall be final and binding, within the Jurisdiction of the Court at Bangalore.
28. The tenderer & supplier should abide the terms & Conditions of the tender.
