The rate quoted by the tenderer for supply of Deltamethrin 2.5% W.P Per kg will be holds good irrespective of the packing. The Deltamethrin 2.5% W.P should conforming to IS: 13457-1992 with up to date amendments & shall be supply to the Regional Managers Offices located at Mysore, Bangalore, Shimoga, Davanagere, Hubli, Kalaburagi and Raichur and Warehouse located at Karnataka state.

### TERMS CONDITIONS AND SPECIFICATIONS

#### 1. SPECIFICATIONS

<b>Description</b>	DELTAMETHRIN 2.5% W.P
<b>Quantity</b>	: The requirement upto 4000 Kgs
<b>Constituents Standard</b>	: The material shall consist of Deltamethrin technical together with suitable carriers, stabilizers and other formulations. Deltamethrin technical, employed in the manufacture of the material, shall confirm to I.S. : 13457-1992 with up to date amendments and ISI marked. Deltamethrin stock should have minimum Deltamethrin content of 2.5% by mass. (Deltamethrin Active ingredient of 2.5% W/W).
<b>Formulation</b>	: Deltamethrin 2.5 % wettable powder.
<b>Description</b>	: The material shall be fine, free flowing, homogeneous powder, free from visible extraneous matter and hard aggregates. It shall wet reading on mixing with water, providing a suspension suitable for use as spray.
<b>Packing</b>	: The material shall be packed in HDPE containers of one KG capacity; such six containers shall be packed in corrugated card board box tough enough to withstand any kind of transit risk. The packing shall also conform to the General requirement IS-18190 (Part-II) 1998 with up to date amendments.
<b>Marking</b>	: The each package / container should have ISI mark. The container shall bear legibly and indelibly the following information in additions to the information as necessary under the insecticides Act, 1968 and Rules framed there under.

**TERMS AND CONDITIONS**

1. The tender for supply of Deltamethrin 2.5% W.P have been invited as per Karnataka Transparency in public procurement Act 1999 and rules 2000. Accordingly two cover bid system consisting of Technical bid and Financial bid shall be followed.

2. The Financial bid of the tenderer shall be opened only of the tenderer who qualifies in the Technical bid.
3. The tenderer should furnish Earnest Money Deposit (E.M.D) through online. The E.M.D shall be liable to be forfeited if the tenderer does not fulfill tender conditions. The EMD amount of successful tenderer will be refunded only after issuing rate accepted letter from this office. The EMD does not carry any interest. The EMD of unsuccessful tenderer will be refunded after finalisation of the Tender.
4. The Successful tenderer shall furnish security deposit @5% of the total value of the ordered quantity by way of Demand Draft drawn in favour of "The Managing Director. KSWC", Bangalore, within 7 days from the date of issuing supply order. The security deposit will be refunded only after one-year from the date of supplied OR supplied quantity exhausted. The security deposit does not carry any interest. The Earned Money Deposit of the successful tenderer shall not be adjusted towards the security deposit and it will not carry any interest.
5. The tenderer should quote rate per Kg in financial bid. Which should be inclusive of GST, Central and State sales tax, excise duty, VAT, octroi charges and all other taxes levied or may be levied in future without submission of form "C" and "D" or any other similar form prescribed under any relevant Act in force and delivery on F.O.R basis to the Regional Manager Offices/Warehouses. The transportation charges, loading & other charges should be borne by the supplier.
6. The rate will not be increased once the rate accepted by the corporation. Any request to increase the rate will not be considered during the one year period or extended period of two months.
7. The tenderer should quote rate Per Kg in financial bid at e-procurement portal. The rate quoted shall be valid for a period of One year and extended period of two months from the date of acceptance of the tender rate.
8. The tenderer who has signed the tender should be present or may depute his / their authorized representative to be present at the time of opening of tender if they so desire, along with the authority letter duly attested.
9. Each tenderer should mention his postal address with pin code, phone number, fax number, e-mail etc. The KSWC will not be responsible for any non-receipt of information furnished by the tenderer with incorrect postal information.
10. The Deltamethrin 2.5% W.P should be dispatched & covered under transit insurance for dispatch to the Regional Manager Offices located at Mysore, Bangalore, Hubli, Davanagere, Shimoga, Gulbarga and Raichur located at Karnataka state.

11. The material should be delivered on F.O.R. basis. In case of any damages or shortages found at the destination, will have to be replaced by the tenderer at free of cost.
12. The supplier should be offered for pre- inspection at a time in his factory or any one of his place in Karnataka or Karnataka State warehouse corporation points within 20 days from the date of supply order. The material shall be of recent manufacture which should not be more than one month old from the date offered for pre-inspection. The inspection officer of the Corporation will be inspect the stores at your factory OR If corporation desires the material should be supplied for any one of the place in Karnataka for pre inspection and to draw the sample at his discretion in respect of supplies to be made and get it tested by any recognized laboratory as decided by the Corporation. The laboratory test charges should be borne by the successful tenderer. Delivery of the Deltamethrin 2.5% W.P to the destination shall be done only after confirmation letter received from the Corporation that the stores confirms to I.S. Specification and dispatches can be made within Seven days from the date of receipt of dispatch order. If the successful tenderer fails to offer for pre-inspection and to deliver the Deltamethrin 2.5% W.P with in the stipulated time, penalty will be imposed as decided by Managing Director, KSWC.
13. The payment for supply of Deltamethrin 2.5% W.P shall be made only after receipt of proof of dispatched documents and receipt of stock certificates from the Regional Managers / Warehouse Managers, that Deltamethrin 2.5% W.P are received in good conditions.
14. The product shall be guaranteed against any deterioration for a period of Two years from the date of manufacture. The product should have same Specifications till expiry of guaranteed period of two Years.
15. If corporation desires the material received at any place, at any time will be drawn sample and sent to lab test. The product should have same Specifications till expiry of guaranteed period of two Years.
16. The successful tenderer should execute an agreement on Stamp paper of value Rupees One hundred for supply of Deltamethrin 2.5% W.P as per tender condition within 7 days from the date of intimation of accepted rate. There should be no escalation clause in the tender.
17. The Managing Director, KSWC reserves the right to accept or reject the tenders or to increase or decrease the quantity of the Deltamethrin 2.5% W.P without assigning any reasons.
18. The successful L1 Tenderer should furnish all the original documents for verification for acceptance of tender. The online documents must be same to the furnished original documents.
19. The technical Bid or Financial Bid will be opened on next working day, if any general holiday declared, if bids are not opened in portal etc... on schedule date.

20. The successful tenderer fails to do or comply with any terms and conditions of the tender, the Managing Director, KSWC shall have all the right to cancel the tender and call for fresh tender. In such case E.M.D and security deposit furnished by the tenderer shall be forfeited without a prejudice to the other right legally available and call for fresh tender at his risk and cost and the tenderer liable to make good the difference or loss to the Corporation.
