Terms & Conditions

1. Tender must be accompanied by an earnest money of Rs.3,000/-(Three Thousand only) in the form of Demand Draft in favour of Managing Director, Karnataka State Warehousing Corporation, Bangalore. Tenders received without earnest money will not be entertained.
2. Earnest money of successful tenderers shall be adjusted towards his/their security deposit for the satisfactory execution of the supply and shall be liable to be forfeited if the successful tenderer(s) regiles from or modifies their offer or terms and conditions of tender in any manner. The earnest money of the un-successful tenderer shall be refunded after the finalisation of the tender at their request.
3. The successful tenderer shall be required to deposit security equal to the 5% of the total value of the supply order within 10 days of issue of the supply order, failing which it shall be lawful for the Corporation either forfeit the earnest money or get the material arranged at his risk and cost. No interest shall be paid on earnest money and the security deposit. The Security deposit will be refunded after one month from the date of last supply
4. Tender shall remain valid for a period for 60 days. Tenderers are required to quote rate only on prescribed tender document. Rates quoted shall be inclusive of all taxes(GST). The supply will have to be arranged within 15 days from the date of supply order as intimated by the corporation to particular Regional Office. This tender period will be six month from the date supply order.
5. The quantity may be increased or decreased at the sole discretion of the Corporation.
6. The supply of locks will be as and when KSWC placed order to the successful tender. Mere acknowledgement/receipt of supply by officials of Corporation will not give the right of acceptance of supply to the supplier unless it is accepted by the competent authority.
7. In case of short or defective supply or both the Corporation shall be entitled at its sole discretion to ask the supplier to complete short or replace defective supply or impose penalty upto 10% of the price of the store (short or defective) and the same shall be recoverable either from the earnest money or the security deposit or from the bills of the suppliers, as the case may be and in case the supplier fails to complete the supplies or replace the defective supplies within the time given by us, the Corporation may take such other measures, including cancellation of the contract and effect the risk purchase at the cost of the tenderer or forfeit the earnest money/security and also legal action. This will be without prejudice to all other rights accruing to the Corporation out^of the contract.
8. The time allowed for delivery will be essence of the contract. In case of delay in execution of the order, the Corporation may cancel the order without any compensation or impose penalty upto 10% of delayed supply. The amount of penalty shall be recoverable either from the earnest money or security or from the pending bills of the supplier or from any other deposits or security etc. lying with the Corporation as the case may be. The decision of the Managing Director shall be final and binding on the tenderer.

- The earnest money/security deposit will however, be refunded in full after the period of one month from the satisfactory execution of the order and on the request of the tenderer.
9. In case of non supply, the Corporation shall be entitled at its sole discretion to effect risk purchase at the cost of tenderer or forfeit earnest money/security or take such other measures as deemed necessary including cancellation of the contract without prejudice to other rights arising out of the contract. The decision of the Managing Director, Haryana State Warehousing Corporation in this behalf shall be final and binding on the tenderer.
 10. Goods received at destination should strictly confirm to the specifications prescribed and shall be liable to be returned if these are not as per specifications, to the suppliers at his risk & cost, without prejudice to the other rights available to the Corporation in this regard.

GENERAL CONDITIONS

1. Rates should be mentioned in figures & words. No over writing should be made. In case of correction, if any it should be duly initiated by the tenderer.
2. The Managing Director of the Corporation reserves the right to accept or reject any or all tender without assigning any reason and also entrust the work to more than one parties/ suppliers.
3. Tenderer should quote the price per one lock.
